**NRCS:** (see attached) Kendall Smith/ Nakayla Lestina – Kendall gave program updates and deadlines. NRCS Craig Field office has been an model for the state regarding the Conservation Planning First initiative. -Local Work group survey will be going out this week – please share with all landowners.

-Nakayla provided the civil Rights checklist for all board members to sign and be on file with our agency agreement. Civil Rights Responsibilities for Partners Checklist was reviewed and signed.
-CFCD board members will set aside the 2<sup>nd</sup> and 3<sup>rd</sup> Friday of the next few months for field days with NRCS staff in order to get more hands on knowledge of local operations. Kacey will make the schedule.

-We have 25 wildlife escape ramps on hand, and the water trailer will be ready by Ag day on May 13.

### **District Manager Report:** Kacey Green

- -NFWF Grant pre-proposal has been submitted, and we should know in a few weeks if we are invited to submit a full proposal.
- -Quarterly DCT Reports and Moffat county 1/4 bill submitted
- -Moffat County Commissioners Workshop will be April 14h, 2:00 PM in the same room. Kacey will have packets for each commissioner, and we will discuss budget and the possibility of increasing our yearly payment from \$12,500 to \$18,500

#### **New Business:**

- Soil Health Initiative updates Nick discussed the hesitation of CACD to support the soil health bill as written. There is concern that CD's will become irrelevant and have to compete for funding through the new grant process. He is following the bill and initiative closely and will keep us updated. Laurel mentioned that part of the initiative is the STAR program (Saving Tomorrow's Agriculture Resources (S.T.A.R.) <a href="https://starfreetool.com/about">https://starfreetool.com/about</a>) This could be a useful tool for landowners as soil health becomes more front and center in ag.
- Upper Yampa Over-appropriation Designation Kacey was able to visit with Will Myers. His suggestion was to have the district educate landowners, focusing mainly on well permits.
   CFCD will work on getting information and education put out on this subject.
- Kacey has been in contact with Jesse Schroeder at MCW&P, to discuss the balance on their weed account. \$25,000 has been sitting idle since January 2018. Jesse was able to receive approval to allow CFCD to use that money. The board discussed using this as matching cash for any grants applied for, and having it as a back-up in case payroll funds get short. (See attached emails)
- CPW has seed drills they are willing to lend out at no cost. Please refer landowners to Colton
  if they have seeding projects
