# CFCD District Meeting 8/3/22 MINUTES

**Meeting was called to order** by board President Wayne Counts at 11:30 am

Minutes from 6/15/22 were read. Colton moved and Nick seconded to approve minutes. Motion passed Treasurer's report and bills were presented. Colton moved and Nick seconded to approve the Treasurer's report and pay the bills, motion passed.

Nick moved and Colton seconded to move excess funds into reserves to meet the statutory requirements as well as earn a higher interest rate. Motion passed

Kacey presented a budget snapshot (attached) which broke out grant income and expenditures. This meeting will focus largely on budget and projects for the remainder of 2022 and into 2023.

#### **STAR Plus:**

- \$2000 per producer per year (next 3 years), provided all producers say enrolled
- Expanded equipment grant ideas were discussed: (soil probe, hay core tool, laser level, mapping drone, post pounder (universal hitch), single ripper shank (squirrels, the compaction equipment will create will be less than damage from the squirrels) Could possible to a deposit/rent items out
- Kacey will put together a proposal to submit to CDA Soil Health Program
- Ken moved and Rod seconded to approve equipment grant and re-imbursement submissions for:
  - o Kawcak, Murray, Camblin and Counts
  - o Motion Passed Kacey will submit

### **CSCB Matching Grant** - \$1000 per project- up to \$1,000.00

- 8 total (4 paid, 1 pending, 4 to approve)
- Grant has been applied for 2023, with the cost share amount raised to \$2500 per project
- Colton Moved and Ken seconded to approve project applications for:
  - o Butler, Raftopoulos, Kawcak

Nick suggested that applications showing soil health improvements should be given greater consideration. Colton mentioned that there is still plenty of money in the pool, but if applications start coming in, then that would be a better time to be more critical. Squirrels are still a huge problem in Moffat County and much discussion followed regarding licensed squirrel control contractors, baits and badger control. Without controlling the squirrels first, not much else can be done to improve soil health. One more consideration for the equipment grant would be a single ripper shank to break up burrows and curb re-infestation. Kacey will follow up with the state board and make sure that contractors can be paid, or if they must be licensed for pest control. Motion passed

  - \$39.63 Chemical
  - = \$55-60 / Acre, and chemical is active for 4 years+
